

TOWNSHIP OFFICERS

Township Officers are elected by the voters of the township who reside outside the corporate limits of a city. Township officers may be residents of a city within the township. Township officers are elected to serve four-year terms on the General Election Ballot.

Township Trustee Duties:

1. Annually prepare and adopt a budget and certify taxes for the following services:
 - a. Fire & Rescue
 - b. Maintenance of Township Cemeteries
 - c. Township Hall Repairs
 - d. Tort Liability Insurance
2. Resolve fence disputes

Township Clerk Duties:

1. Maintain a record of all proceedings and orders of the trustees
2. Maintain records and documents
3. Prepare annual Statement of Receipts and Disbursements
