**ORDINANCE NUMBER 121**

An Ordinance of the Mahaska County Board of Supervisors establishing the voting precincts of Mahaska County, Iowa.

WHEREAS the Board of Supervisors of Mahaska County, Iowa is empowered and directed by Chapter 49.7 of the Code of Iowa to determine and establish the voting precincts for Mahaska County, Iowa; and

WHEREAS the census for the year 2000 has now been completed.

NOW THEREFORE BE IT ORDAINED by the Mahaska County Board of Supervisors that the voting precincts of Mahaska County, Iowa, outside the city limits of the City of Oskaloosa, Iowa, be and hereby are established as follows:

PRECINCT NUMBER ONE:	Adams Township
PRECINCT NUMBER TWO:	Black Oak Township and Scott Township
PRECINCT NUMBER THREE:	Cedar Township

PRECINCT NUMBER FOUR: Jefferson Township  
East Des Moines Township and  
West Des Moines Township

PRECINCT NUMBER FIVE: Garfield Township

PRECINCT NUMBER SIX: Harrison Township

PRECINCT NUMBER SEVEN: Madison Township and  
Lincoln Township

PRECINCT NUMBER EIGHT: Monroe Township and  
White Oak Township

PRECINCT NUMBER THIRTEEN: Union Township and  
Pleasant Grove Township

PRECINCT NUMBER FOURTEEN: Prairie Township

PRECINCT NUMBER FIFTEEN: Richland Township

PRECINCT NUMBER SIXTEEN: Spring Creek Township

PRECINCT NUMBER SEVENTEEN: The Town of University Park
