# January 7, 2002

The Mahaska County Board of Supervisors met on the above date at 9:00 a.m. in the third floor conference room of the Mahaska County courthouse. The following Board members were present: Howard Groenendyk, Henry W. VanWeelden, Greg Gordy. Also present were the following: Jon Lubke, Information Technology Dept.; Kay Swanson, County Auditor and Lawrence Rouw. Chairman Groenendyk called the meeting to order with a moment of silence.

It was moved by Gordy seconded by VanWeelden to approve the agenda with the removal of the item to approve minutes. All ayes. Motion carried.

It was moved by VanWeelden seconded by Gordy to approve the bills for December in the amount of \$1,121,275.06 and payroll in the amount of \$345,068.67. All ayes. Motion carried.

It was moved by Gordy seconded by Groenendyk to appoint Henry W. VanWeelden as chairperson for 2002. All ayes. Motion carried. It was moved by Groenendyk seconded by VanWeelden to appoint Greg Gordy as Vice-Chair for 2002. All ayes. Motion carried. Chairman VanWeelden took over the meeting at this time.

It was moved by Gordy seconded by Groenendyk to set the first Monday and third Monday of each month at 9:00 a.m. for the regular meeting dates and that other meetings will be held as necessary. All ayes. Motion carried.

It was moved by Groenendyk seconded by Gordy that following the board meeting on the third Monday of each month that a working session be held with the Engineer. All ayes. Motion carried.

It was moved by Gordy seconded by Groenendyk that in the absence of the Chairman any of the Board members have the authority to sign documents for the County. All ayes. Motion carried.

It was moved by Gordy seconded by Groenendyk to name the Auditor and the Board of Supervisors as custodians of the courthouse. All ayes. Motion carried.

It was moved by Gordy seconded by Groenendyk to set the following 9 ½ days for holidays for when the courthouse will be closed in 2002. All ayes. Motion carried. New Years Day January 1<sup>st</sup>, Presidents Day February 18<sup>th</sup>, Memorial Day May 27<sup>th</sup>, Independence Day July 4<sup>th</sup>; Labor Day September 2<sup>nd</sup>, Veterans Day November 11<sup>th</sup>; Thanksgiving Day and Friday after November 28<sup>th</sup> and 29<sup>th</sup>, ½ day Christmas Eve Day December 24<sup>th</sup> and Christmas Day December 25<sup>th</sup>. All ayes. Motion carried.

It was moved by Groenendyk seconded by VanWeelden to reappoint Kay Swanson, Auditor and Greg Gordy, Supervisor as Trustee and Alternate respectively to the Heartland Risk Insurance Board. All ayes. Motion carried. It was moved by Gordy seconded by Groenendyk to name the Oskaloosa Herald, New Sharon Star and Fremont Gazette as the official newspapers for the year 2002 for Mahaska County. All ayes. Motion carried.

It was moved by Gordy seconded by Groenendyk to approve the following resolution naming the depositories for County funds for the various offices for 2002 and till there is a need to increase the same. All ayes. Motion carried.

Salary will be \$66,906.00 for fiscal year 2002; \$70,920.00 for fiscal year 2003 and \$75,175.00 for fiscal year 2004. All ayes. Motion carried.

It was moved by Groenendyk seconded by Gordy to allow the new county engineer to work Tuesday and Thursday for his former employer with adjusted pay for Feb. 12<sup>th</sup> and 14<sup>th</sup>; Feb 19<sup>th</sup> and 21<sup>st</sup>; Feb 26<sup>th</sup> and 28<sup>th</sup> and March 5<sup>th</sup> and 7<sup>th</sup>. It was moved by Gordy seconded by Groenendyk to approve the request of the sheriff to place Trevor Wells on the payroll as deputy sheriff effective January 2, 2002 at a salary of \$36,250.00. All ayes. Motion carried.

RESOLUTION REQUESTING THAT THE LEGISLATURE AMEND THE CODE OF IOWA TO RETURN THE OFFICE OF THE CLERK OF DISTRICT COURT TO THE COUNTIES

WHEREAS a plan has been proposed by the Judicial Council of the State of Iowa to restructure the Court System in Iowa; and

WHEREAS the plan would require that approximately 70 rural Clerk of the District Court offices be closed except for trials and magistrate court sessions; and

WHEREAS criminal prosecutions would take place at a court service center requiring extensive travel at great additional expense to the victims of crimes, witnesses, law enforcement personnel and county taxpayers; and

WHEREAS the residents of Mahaska County and other rural counties would be required to travel additional miles to obtain court services and pay additional taxes to fund the additional travel by court officials; and

WHEREAS the Clerks of Court were for many years elected county officials funded in part by criminal fines and court costs collected by those offices; and

WHEREAS after the Clerks of Court became state employees, the fines began to go to the State; and

WHEREAS functions of the Court should serve the citizens of this State and not the Court Officials; and

WHEREAS it is in the best interests of the residents of Mahaska County and the residents of other rural counties that Court services be provided efficiently and locally; and

WHEREAS it appears that the State Judicial Branch is unable or unwilling to budget and provide for adequate court services to rural residents; and

WHEREAS local county government has proven itself to be able to provide competent and efficient services to county residents.

NOW THEREFORE BE IT RESOLVED that the Mahaska County Board of Supervisors respectfully requests that the legislature amend the Code of Iowa to return the offices of the Clerks of the District Court to county control and further provide that the criminal fine moneys and costs collected by the respective Clerks be again remitted to the counties to fund the offices of the Clerk of District Court.

### AGREEMENT

By and between the City of Oskaloosa and Mahaska County;

The City of Oskaloosa and Mahaska County entered into an agreement dated June 15, 1987 (copy attached) regarding repayment by the City of Oskaloosa to Mahaska County for expenses related to the paving of 35<sup>th</sup> Street if the City of Oskaloosa annexed land adjacent to the street. The City of Oskaloosa did annex land in 1999 in conjunction with the World Food Park development. Due to this annexation, it has been calculated that the City of Oskaloosa should reimburse Mahaska County in the amount of \$53,655.17.

The City of Oskaloosa and Mahaska County agree that this amount shall be paid in three installments as follows:

Payment 1: On or before January 15, 2002 - \$17,885.06

Payment 2: On or before October 15, 2002 - \$17,885.06

Payment 3: On or before October 15, 2003 - \$17,995.05
