### March 18, 2002

The Mahaska County Board of Supervisors met on the above date at 9:00 a.m. in the third floor conference room of the Mahaska County courthouse. Present were the following board members: Howard Groenendyk, Greg Gordy and Henry W. VanWeelden. Also present were: Michelle Moore, Mahaska County Agricultural and Rural Development Committee; Mike Gipple, County Conservation Dept.; Marie Ware, Mahaska County Recreation Foundation; Josh Spears; Jerome Nusbaum, County Engineer and Kay Swanson, County Auditor. Chairman VanWeelden opened the meeting with a moment of silence.

It was moved by Gordy seconded by Groenendyk to approve the agenda with the deletion of approval of the March 13<sup>th</sup> minutes and adding the resolution for setting land and fence prices. All present voted aye. Motion carried.

It was moved by Gordy seconded by Groenendyk to approve the minutes of March 4<sup>th</sup> and 8<sup>th</sup>. All present voted aye. Motion carried.

It was moved by Gordy seconded by Groenendyk to approve the revised monthly report for the month of January and the monthly report for February for the Veterans Affairs Commission. All present voted aye. Motion carried.

Michelle Moore from the Mahaska County Agricultural and Rural Development Committee gave her monthly report to the board.

The supervisors discussed the committee meetings that each had attended recently.

## MANAGEMENT AGREEMENT MAHASKA COUNTY

THIS AGREEMENT entered into on March 8, 2002 by and between the Mahaska County Board of Supervisors and the Mahaska County Conservation Board (MCCB).

WHEREAS, the Mahaska County Board of Supervisors, having need for maintenance of land in the interest of the people of Mahaska County; and

WHEREAS, the Mahaska County Conservation Board, currently having the personnel, adequate equipment and ability to maintain parks and similar public lands; and

WHEREAS, both parties agree that it is in the best public interest to transfer maintenance responsibilities to the MCCB pursuant to the terms of this AGREEMENT.

WITNESSETH:

- 1. The Mahaska County Conservation Board shall maintain the grassy portions of the lot, owned by Mahaska County, at the location of the Mahaska Building, Oskaloosa, Iowa.
- 2. MCCB management and maintenance shall be limited to routine lawn maintenance within the boundaries of land owned by Mahaska County.
- 3. The Mahaska County Board of Supervisors agrees to have the lawn chemically treated for non-desirable vegetation at no expense to the MCCB.
- 4. The agreement may be terminated by written consent and agreement by both parties.
  - 5. This agreement shall be renewed annually and expire October 31, 2002.

# RESOLUTION MAHASKA COUNTY BOARD OF SUPERVISORS

WHEREAS, Southern Iowa for years have been utilizing Amtrak with a total of 55,403 passengers in 2001, and;

WHEREAS, Mahaska County has valued their service to rural Iowa and support Federal Subsidizing of the Amtrak California Zephyr and the Southwest Chief and;

WHEREAS, the Mahaska County Board of Supervisors are very concerned with the restructuring plans of Amtrak that could cause a major shift in the philosophy that the rail service was founded on, and;

WHEREAS, this shift from rural America to more Urban area routes will further isolate and cripple the transportation systems in Southern Iowa, and;

WHEREAS, the Amtrak already has a large investment in Southern Iowa through rails and equipment, the Mahaska County Board of Supervisors support a high speed passenger rail line being added through Southern Iowa to improve profitability, and;

WHEREAS, with the Homeland Defense the United States of America should not rely soley on airline and automobile transportation systems and should allocate additional funding for passenger rail service as they have done for the airlines; NOW THEREFORE BE IT

RESOLVED that the Mahaska County Board of Supervisors hereby endorse a federal subsidy for passenger rail service and a high speed passenger rail line through Southern Iowa.

The Keokuk county portion was reverted back to Josh Spears. It was moved by Groenendyk seconded by Gordy to close the public hearing. All present voted aye. Motion carried.

No decision was made today. It will be on the April 1, 2002 meeting agenda.

It was moved by Groenendyk seconded by Gordy to accept the following assignment. All presented voted aye. Motion carried.

#### ASSIGNMENT

COMES NOW South Central Mental Health Center, by its Board of Directors, and does hereby assign to Mahaska County Board of Supervisors, the following:

- 1. Any and all income, refunds, reimbursements, or any other receipts whatsoever, that might be payable to South Central Mental Health.
- 2. Said assignment is based on the specific condition that the Mahaska County Board of Supervisors shall from said proceeds and other funds paid over to Mahaska County, pay any and all bills, obligations, and debts of South Central Mental Health Center.
- 3. That to the knowledge of the Board of Directors, the only obligations or debts remaining would be Schuring & Uitermarkt, C.P.A., P.C., and any unpaid fees due Life Law Office, if not previously paid, however shall include any other unknown debts or obligations of South Central Mental Health Center, not to exceed the amount of funds turned over to the county.

### RESOLUTION

**WHEREAS**, a position in the Mahaska County Secondary Road Department for Hydraulic Excavator Operation was filled by the appointment of an individual to that position in October, 2001; and

**WHEREAS**, thereafter, another candidate for the position filled, Daryl Cox, filed action claiming a veterans preference to the position filled in the lawsuit entitled <u>Daryl Cox v. Mahaska County</u>, <u>Equity No. EQEQ084248</u>, filed on October 30, 2001; and

- WHEREAS, investigation into the circumstances surrounding the contested appointment to the above-referenced position revealed that, by error and inadvertence, the application of Daryl Cox had not been considered during the original hiring process; and
- WHEREAS, to avoid any claims of bias or prejudice in re-consideration of all applicants to the above-referenced position, and to determine the best qualified candidate for that position given the pendency of the above-referenced Cox litigation, the Mahaska County Board of Supervisors contracted with the Keokuk County Engineer and her staff to independently review all such applications, interview such candidates and recommend to this Board those candidates most qualified for the job position; and
- **WHEREAS**, the Keokuk County Engineer and her staff have finally ranked those applicants for that position from most to least qualified; and
- **WHEREAS**, the Iowa Veterans Preference law, Iowa Code Section 35C.1(1), provides a preference in appointment to qualified veterans "over applicants of no greater qualifications" and the qualifications of other applicants have been determined by the Keokuk County Engineer and her staff to be greater than those of Mr. Daryl Cox;
- **NOW, THEREFORE, BE IT HEREBY RESOLVED,** that the March 3, 2002 recommendations to the Board by the Keokuk County Engineer and her staff are hereby accepted; and
- **BE IT FURTHER RESOLVED,** that the preference claimed to the above-referenced job position by Mr. Daryl Cox under the Veterans Preference Statute is rejected; and
- **BE IT FURTHER RESOLVED,** that Josh Thornbrugh is hereby appointed to the position of Hydraulic Excavator Operator in the Mahaska County Secondary Road Department; and
- **BE IT FINALLY RESOLVED,** that letters to all applicants shall be sent notifying each of them of this Resolution and thanking them for their interest in the position
