RESOLUTION PROVIDING FOR THE FINANCIAL SUPPORT OF THE AREA 15 REGIOINAL PLANNING COMMISSION

WHEREAS, the governing body of Mahaska County is a part of the Area 15 Regional Planning Commission and has agreed to contribute \$.25 per capita, for a total amount equal to 2,849.25 to cover financial operating costs of the Area 15 Regional Planning Commission from July 1, 2003 through June 30, 2004.
