RESOLUTION

To Approve Application for TEA-21 Federal Funds For Reconstruction of Mahaska County Highway G5T

WHEREAS, the Mahaska County Board of Supervisors desires to maintain a quality road system; and

WHEREAS, certain roads in the local system are eligible for improvement under the federal TEA-21 program; and

WHEREAS, the Board of Supervisors must approve all applications for federal funding and commit to provide local funds to the proposed budget.

NOW, THEREFORE BE IT RESOLVED, that the Mahaska County Board of Supervisors does hereby approve applications be submitted to the Area XV Regional Planning Commission for TEA-21 funds to recycle existing concrete pavement and construct new concrete paving for Mahaska County Highway G5T from Adams Avenue East and north to the Skunk River bridge.

BE IT FURTHER RESOLVED that the Board of Supervisors does commit to providing the local match for the project.
