RESOLUTION

WHEREAS, Donald DeBruin and Patricia DeBruin are owners of farmland in the Southwest Quarter of the Northeast Quarter of Section 35, Township 76, Range 16; and

WHEREAS, such owners intend to construct a 1200 head finishing house with confinement pit for swine waste; and

WHEREAS, the topography of such land dictates a proper and reasonable placement of such structure, which would have a part of such structure less than one hundred feet (100') from the right-of-way of 210th Street; and

WHEREAS, Section 459.205 2 provides that the County may execute a written waiver of existing requirements for distance separation from existing right-of-ways; and

WHEREAS, investigation indicates a fifty-foot (50') distance separation at such site would be in the public interest;

BE IT THEREFORE RESOLVED, that the Mahaska County Board of Supervisors waives the requirement that the above landowners maintain a one hundred foot (100') separation of their hog facility from 210th Street and consent to a separation distance of fifty (50') feet.
