It was moved by VanWeelden seconded by Gordy to approve the monthly report for the Veterans Affairs Dept. for September 2004. All present voted aye. Motion carried.

It was moved by Gordy seconded by VanWeelden to approve the request of the Sheriff to remove Emmy Voss as jailer effective October 9, 2004. All present voted aye. Motion carried.

It was moved by VanWeelden seconded by Gordy to offer flu shots to the employees of Mahaska County if the vaccine is available. All present voted aye. Motion carried.

It was moved by Gordy seconded by VanWeelden to sign the H. E.R.O. Proclamation designation of the month of October. All present voted aye. Motion carried.

It was moved by VanWeelden seconded by Gordy to reject all applications for the maintenance and custodial position that had been advertised for. All present voted aye. Motion carried.

It was moved by VanWeelden seconded by Gordy to donate the courthouse pickup to the Mahaska County Conservation Dept. but for the county to keep the blade and the sander. All present voted aye. Motion carried.

The board and county engineer discussed the 28E City – County Agreement draft.

It was moved by Gordy seconded by VanWeelden to purchase a side dump trailer and the engineer to purchase and the City will share in the cost of the trailer. All present voted aye. Motion carried.

It was moved by Rouw seconded by Gordy to share 50-50 with MCRF the cost of the bridge planks for the bike trail. All present voted aye. Motion carried.

The board discussed the following during the work session with the engineer: That the edge drains on G5t are done and waiting for stripping on that part of the road. Putting signs back up on G5T.
