## **December 20, 2004**

Chairman Rouw called the meeting to order with a moment of silence.

It was moved by VanWeelden seconded by Gordy to approve the agenda. All present voted aye. Motion carried.

It was moved by Gordy seconded by VanWeelden to approve the minutes of December 6, 2004. All present voted aye. Motion carried.

Michelle Moore from the Mahaska County Agricultural and Rural Development Committee gave the board her monthly report. She discussed the grants that had been done for a restroom facility at the fairground and a building at the Nelson Pioneer Farm.

It was moved by VanWeelden seconded by Rouw to approve the contract with ArrowQuick for information technology services beginning January 1, 2005. Two – Aye One – Nay. Motion carried.

It was moved by Gordy seconded by VanWeelden to approve the Risk Pool Agreement for Heartland Insurance Risk Pool. All present voted aye. Motion carried.

It was moved by VanWeelden seconded by Rouw to approve the appointment of Randy DeGeest and Greg Gordy to the Board of Health for three year terms expiring December 31, 2007. All present voted aye. Motion carried.

It was moved by Rouw seconded by VanWeelden to reduce the recommendation of the Compensation Board for salaries of the elected officials by 50% for each official. Attorney; Auditor; Recorder Sheriff, Treasurer and Supervisors. All present voted aye. Motion carried.

It was moved by Rouw seconded by VanWeelden to approve the request of the Engineer to hire Reid Stevens as Engineering Technician beginning January 3, 2005 at \$11.57 per hour for 6 months then \$13.01 for the next 6 months. The position will end at December 31, 2005. All present voted aye. Motion carried.

It was moved by Rouw seconded by VanWeelden to increase the hourly rate to \$13.75 effective January 3, 2005 for Troy Bemis and to name him as Head Maintenance Person. All present voted aye. Motion carried.

It was moved by VanWeelden seconded by Gordy to adjourn. All present voted aye. Motion carried.
