28E Agreement Mahaska County and Mahaska County Hospital DBA Mahaska Health Partnership

The Mahaska County Hospital, a public hospital as defined in Iowa Code Chapter 347, as empowered under Chapter 347.14(13), and in the mutual exchange promises and other valuable consideration enter this 28E agreement with Mahaska County, a political subdivision of the State of Iowa by and through the Mahaska County Board of Supervisors, to effect a "general county purpose" as defined in the Iowa Code Chapter 33 1.441 and;

Whereas the Mahaska County Board of Supervisors desires to provide a Advanced Level county wide ambulance service, and;

Whereas the Mahaska County Board of Supervisors further desires to have such services under the supervision and direction of the Mahaska County Hospital DBA Mahaska Health Partnership Board of Trustees, and;

Mahaska County Hospital DBA Mahaska Health Partnership Board of Trustees agrees to provide the supervision of said services known as the Mahaska Hospital Emergency Services DBA Mahaska Ambulance.

Therefore, be it resolved by both entities as follows:

That the Mahaska County Hospital DBA Mahaska Health Partnership Board of Trustees agrees to operate the Mahaska Hospital Emergency Services DBA Mahaska Ambulance.

The purpose of this 28E Agreement is to make a uniform standard for a county-wide ambulance service which is directly responsible to the Mahaska County Board of Trustees and the Mahaska County Board of Supervisors. The day to day operation, maintenance, purchase, and decision making processes for the emergency medical ambulance services shall be delegated by the Board of Trustees for Mahaska County Hospital DBA Mahaska Health Partnership to the chief executive officer of the hospital who shall be responsible for the establishment and maintenance of a budget for the emergency medical ambulance service.

This agreement, once ratified by both entities, may be terminated by either party by giving 6 months written notice delivered to either the Auditor for the Mahaska County Board of Supervisors or the Administrator for the Mahaska County Hospital DBA Mahaska Health Partnership and the Chairman of the County Hospital DBA Mahaska Health Partnership Board of Trustees.

In accordance with Chapter 28E of the Iowa Code, a copy of this agreement shall be filed with the Secretary of State and recorded with Mahaska County Recorder.
