September 3, 2013

The Mahaska County Board of Supervisors met in regular session on the above date at 9:00 a.m. in the third floor conference room of the Mahaska County courthouse. Present were the following board members: Chairman ó Greg Gordy; Vice chairman ó Mike Vander Molen and Member - Mark Doland. Also present were Duane Nollen, Osky Herald; Ken Allsup, Osky News; Aaron Riggs and Eduardo Zamarripa, CRI; Jerry Nusbaum, Mahaska County Engineer; Reid Stevens, Mahaska County Engineers Office; Brad Reiman, Bearence Management Group and Susan Brown, Mahaska County Auditor.

Chairman Gordy opened the meeting at 9:00 a.m. with a moment of silence.

It was moved by Vander Molen seconded by Doland to approve the agenda for today meeting. All present voted aye. Motion carried.

It was moved by Doland seconded by Vander Molen to approve bills for August in the amount of \$1,162,370.16. All present voted aye. Motion carried.

It was moved by Vander Molen seconded by Doland to approve the minutes of August 19th meeting. All present voted aye. Motion carried.

Creation of Capital Improvement Fund was tabled to the September 16th meeting.

Brad Reiman, Bearence Management Group, was present at the meeting to present a transitional proposal to the board in regard the need to change the third party plan administrator for the Mahaska County Employee Health Plan. Current TPA First Administrators, Inc. will be discontinuing service as of December 31st of this year.

It was moved by Vander Molen seconded by Doland to select Wellmark, which includes Classic Blue and Catamaran, as Third Party Administrator for the Mahaska County Employee Health Plan effective November 1st, 2013. All present voted aye. Motion carried.

It was moved by Vander Molen seconded by Doland to designate Wellmark to collect, report and remit the transitional reinsurance program fee which will be assessed by the U.S. Dept. of Health & Human Services in calendar years 2014, 2015 and 2016. This fee is \$5.25 per member per month plus \$.25 per member per month for the reporting. All present voted aye. Motion carried.

It was moved by Vander Molen seconded by Doland to eliminate the AIG/Chartis transplant benefit as this is included in the Wellmark. All present voted aye. Motion carried.

It was moved by Doland seconded by Vander Molen to select Ameritas Option 1 for the health plan¢s dental program effective November 1st, 2013. All present voted aye. Motion carried.

It was moved by Doland seconded by Vander Molen to select Ameritas Option 1 for the health planøs vision program effective November 1st, 2013. All present voted aye. Motion carried.
