The Mahaska County Board of Supervisors met in regular session on the above date at 9:00 a.m. in the third floor conference room of the Mahaska County courthouse. It was moved by Doland seconded by Gordy to approve the agenda for todayøs meeting. All present voted aye. Motion carried.

It was moved by Doland seconded by Gordy to approve minutes from December 1st meeting. All present voted aye. Motion carried.

It was moved by Vander Molen seconded by Doland to approve 5,234 homestead credit claims (including 6 disabled veterans homestead claims) and 1,031 military claims for tax credit along with 5,119 family farm applications and 11,443 agricultural land applications for fiscal year taxes payable 2015-2016. All present voted aye. Motion carried.

Mark Groenendyk discussed fence line at the county farm property with the board.

It was moved by Doland seconded by Vander Molen to approve increase in wage from \$45,000/yr to \$47,500/yr for Assistant County Attorney Amber Rivera as she has completed her probationary period. All present voted aye. Motion carried.

No action taken on elevator options referred to the county by Kone Inc.
