November 16, 2015

The Mahaska County Board of Supervisors met in regular session on the above date at 9:00 a.m. in the third floor conference room of the Mahaska County courthouse. This meeting was filmed by Communications Research Institute of William Penn University.

Chairman Doland opened the meeting at 9:00 a.m. with a moment of silence.

It was moved by Vander Molen seconded by VanWeelden to approve the agenda for todayø meeting. All present voted aye. Motion carried.

Chairman Doland pointed to a correction needed in the October 28th minutes. Salary for Community Services Director should be \$53,560. It was moved by VanWeelden seconded by Vander Molen to approve minutes from November 2nd and 9th and October 28th as amended. All present voted aye. Motion carried.

Dave Sedivec presented Conservation Department report and it was placed on file.

Deann DeGroot presented MCARD report and it was placed on file.

It was moved by VanWeelden seconded by Vander Molen to approve MCO contracts with United Health Care and AmeriGroup as presented by Heather Gross, Community Services Director. All present voted aye. Motion carried.

Courthouse security priorities were discussed. It was moved by VanWeelden seconded by Vander Molen to assign Troy Bemis as Security Manager. All present voted aye. Motion carried.

Jon Nelson and Andy Baker of Oskaloosa Central Reformed Church spoke to board about possible use of the residential care facility as a transitional housing facility.

Board moved forward in setting a timeline and groundwork for selling residential care facility and county farm property at auction. Chairman Doland will talk to county attorney and see if outside counsel will be needed. Supervisor VanWeelden will talk to sanitarian regarding lagoon and check on need for survey. Water and power will be disconnected at the end of November. It was moved by Vander Molen seconded by Doland to remove all insurance coverage except liability for the facility. All present voted aye. Motion carried. Consensus of the board is to not include Mahaska Community Recreation and Early Childhood Education Center project on the unincorporated area¢ ballot for the local option sales tax renewal but to be in discussion at budget time to see how the county might support.
