It was moved by Vander Molen seconded by Doland to approve minutes for July 5th meeting. All present voted aye. Motion carried.

It was moved by Vander Molen seconded by Doland to accept Recorder¢s 4th qtr and annual report and Treasurer¢s semi-annual and annual reports for FY16. All present voted aye. Motion carried.

Medical: Single \$419 \(\) Family \$1022; Dental: Single - \$30 \(\) Family \$70; Vision: Single \$11 \(\) Family \$22; Employee Life: \$2.20. No change from FY16. All present voted aye. Motion carried.
