All have a vested interest in the district and encouraged the board to consider the students and needs of the district in making their decision on the Prairie Winds TIF plan.

RESOLUTION NO. 2018-15

A resolution to declare necessity and establish an urban renewal area, pursuant to Section 403.4 of the Code of Iowa and approve urban renewal plan and project for the Prairie Wind Urban Renewal Area

WHEREAS, as a preliminary step to exercising the authority conferred upon Iowa counties by Chapter 403 of the Code of Iowa, the "Urban Renewal Law", a county must adopt a resolution finding that one or more economic development areas exist in the county and that the development of such area or areas is necessary in the interest of the public health, safety or welfare of the residents of the county; and

WHEREAS, it has been recommended that an urban renewal area be established within the property described in Exhibit A to this Resolution; and

WHEREAS, notice of a public hearing by the Board of Supervisors on the question of establishing the area identified above as an urban renewal area and on a proposed urban renewal plan and project for the area was heretofore given in strict compliance with the provisions of Chapter 403 of the Code of Iowa, and the Board has conducted said hearing; and

WHEREAS, copies of the urban renewal plan, notice of public hearing and notice of a consultation meeting with respect to the urban renewal plan were mailed to each Community School District in the County; the consultation meeting was held; and responses to any comments or recommendations received following the consultation meeting were made as required by law;

NOW, THEREFORE, It Is Resolved by the Board of Supervisors of Mahaska County, Iowa, as follows:

- Section 1. An economic development area as defined in Chapter 403 of the Code of Iowa is found to exist within the property described in Exhibit A.
- Section 2. The area identified in Section 1 hereof is hereby declared to be an urban renewal area, in conformance with the requirements of Chapter 403 of the Code of Iowa, and is hereby designated the Prairie Wind Urban Renewal Area.
- Section 3. The development of this area is necessary in the interest of the public health, safety or welfare of the residents of Mahaska County, Iowa.
 - Section 4. It is hereby determined by this Board of Supervisors as follows:
 - A. The proposed urban renewal plan conforms to the general plan of the County as a whole;
 - B. Proposed economic development in the urban renewal area is necessary and appropriate to facilitate the proper growth and development of the County in accordance with sound planning standards and local community objectives.
- Section 5. The urban renewal plan for the Prairie Wind Urban Renewal Area is made a part hereof and is hereby in all respects approved in the form presented to this Board, and the proposed project for such area based upon such plan is hereby in all respects approved.

Section 6. All resolutions or parts thereof in conflict herewith are hereby repealed, to the extent of such conflict.

Legal Description - Mahaska County Road Improvement Urban Renewal Area

- 1. The right-of-way of certain portions of County Roads T-38, G-5T, G-29, Osburn Avenue, G-71, G-77 and 267th Street, as more specifically shown on an attachment to the Urban Renewal Plan
- 2. All property on which a wind turbine has been constructed in the County, as more specifically shown on the attachment to the Urban Renewal Plan

RESOLUTION NO. 2018-16

Setting date for a public hearing on ordinance providing for the division of taxes levied on taxable property in the Prairie Wind Urban Renewal Area

WHEREAS, pursuant to rules of Mahaska County, before an ordinance may be considered by the Board of Supervisors, a public hearing must be held on the ordinance; and

WHEREAS, an ordinance has been prepared related to designating certain property in the Prairie Wind Urban Renewal Area as a tax increment district;

NOW, THEREFORE, Be It Resolved by the Board of Supervisors of Mahaska County, Iowa, as follows:

This Board will meet at the Mahaska County Courthouse, Oskaloosa, Iowa, on the 1st day of October, 2018, at 9:00 o'clock a.m., at which time and place it will hold a public hearing on an ordinance providing for the division of taxes levied on taxable property in the Prairie Wind Urban Renewal Area

Notice of the hearing, the same being in the form attached to this resolution, shall be published in a legal newspaper of general circulation in Mahaska County, which publication shall be not less than four (4) nor more than twenty (20) days before the date of the hearing.
