The Mahaska County Board of Supervisors met in regular session on the above date at 9:00 a.m. in the third floor conference room of the Mahaska County courthouse. Present were the following board members: Chairman – Mark Groenendyk; Vice chairman – Steve Wanders and Member – Steve Parker. Also present were Russ VanRenterghem, Sheriff; Andrew Ritland, Attorney; Darin Hite, IT; Curt & Lorie Jager; Bhooshan Karnik, Ryan Davis, McClure Engineering; Harold Fynaardt; John Bandstra and Susan Brown, Mahaska County Auditor. Roger Shindell attended by telephone. This meeting was live streamed by Communications Research Institute of William Penn University.

The Pledge of Allegiance was recited to open meeting.

It was moved by Wanders seconded by Parker to approve the agenda for today's meeting. All present voted aye. Motion carried.

It was moved by Parker seconded by Wanders to open bids for sale of county property .68 acres N of 340th St and E of 330th St near Eddyville and to give the option to bidders to raise their offer. All present voted aye. Motion carried.

Two bids were opened. One from Roman Nahaylo - \$4,205. One from Jager Land & Livestock - \$5,000. Bidders were given option to raise offer – none received. It was moved by Wanders seconded by Parker that board acknowledges high bid to be \$5,000 from Jager Land & Livestock. All present voted aye.

It was moved by Wanders seconded by Parker to open public hearing for sale of property .68 acres N of 340th St and E of 330th St near Eddyville. No written or oral comments were received. It was moved by Wanders seconded by Parker to close public hearing.

It was moved by Wanders seconded by Parker to accept the bid on property .68 acres N of 340th St and E of 330th St near Eddyville from Jager Land & Livestock for \$5,000. All present voted aye. Motion carried.

It was moved by Wanders seconded by Groenendyk to approve the minutes of July 20 & 29. Groenendyk, Wanders – aye. Parker – abstain. Motion carried.

It was moved by Wanders seconded by Parker to approve the bills for the month of July in total \$1,324,299.17. All present voted aye. Motion carried.

It was moved by Wanders seconded by Parker to approve Resolution #2020-18 Mahaska County Section 125 Premium Only Plan document and adoption. All present voted aye. Motion carried.

It was moved by Parker seconded by Wanders to adjourn. All present voted aye. Motion carried.
